

## **Art in a Flash Scratch Off – Official Rules**

1. Promotion begins March, 1 2009 and ends December 31, 2009.
2. Open to legal residents of the United States who are at least 18 years of age at the time of entry. Employees, officers, and trustees of the Columbus Museum of Art and their immediate family members are not eligible to participate.
3. Art in a Flash cards are received in thanks for donating at least \$10 to CMA Annual Fund. Participants will receive one card for every \$10 donated. Donations can be made at CMA located at 480 East Broad St., Columbus, Ohio 43215 in the Museum Shop, the Admission Desk or through individual volunteers of CMA.
4. **No purchase necessary**. You can obtain an Art in Flash scratch off card by sending a self addressed/stamped envelope to: Art in Flash at CMA, 480 East Broad St., Columbus, Ohio 43215. One card will be send to one person per address. Request must be received by December 20, 2009. CMA is not responsible for lost, late, misdirected, incomplete or illegible mail.
5. Prizes must be claimed by December 31, 2009 in person at CMA.
6. Prizes are non-transferable.
7. The winning card has to be determined valid by CMA.
8. Must present original scratch-off card to claim prize.
9. CMA reserves the sole right to change, add or delete any prizes at any time. CMA does not make any warranty, representation or guarantee express or implied, with respect to any prize, including, without limitation, to such prize's quality or fitness for a particular purpose.

CMA reserves the right, without prior notice and at any time, to terminate the promotion, in whole or in part, or modify, suspend or extend the promotion in any way, or declare certain cards void and invalid if it determines, in its sole discretion, that the cards in question reflect printing or other errors or if it determines, in its sole discretion, that the cards are impaired or corrupted or that fraud or technical problems, failures or malfunctions (including, without limitation, printing or production errors) have destroyed or severely undermined the proper play, integrity, and/or feasibility of the promotion.
